

## **Magellan Flagship Fund Limited ('MFF') Weekly Net Tangible Assets ('NTA')**

MFF advises that its approximate weekly NTA per share as at Friday, 07 February 2014 was \$1.481 (cum interim 1 cent per share, unfranked dividend), excluding net tax liabilities of approximately \$0.136<sup>1</sup> (\$1.345 per share after tax).<sup>2</sup>

Note that no adjustments are made for future exercises of the MFF 2017 options (exercise price \$1.05 per option). The approximate pre tax NTA would have been reduced by approximately 10.0 cents per share if all of the MFF 2017 options had been exercised on Friday, 07 February 2014.
